

- EVgo conducts DEI training on various topics including overcoming racism and anti-harassment


We believe the only way to achieve our vision of "Electric for All" is to utilize the strength that comes from the richness of diverse perspectives and an inclusive culture.





#### PROMOTING SUSTAINABLE COMMUNITIES:

- EVgo's goal is to ensure that EVs and public fast charging are accessible to all
- EVgo's Charging for Change program is designed to promote sustainable communities through public education and expanded access to EV fast charging, with an emphasis on building charging stations in communities with disproportionate pollution burden
- Over 50% of stalls on the EVgo network serve an environmental justice impacted community, which means an EVgo charger is within a 10-minute drive\*

\*As of 9/30/2023. Environmental justice impacted communities are defined as more diverse, less affluent, and more impacted by air pollution (PM2.5 > 50) than the average neighborhood in a given geography according to the U.S. EPA's Environmental Justice Screening and Mapping Tool (EJScreen).

### **GOVERNANCE**

Leading Through Strong Ethics and Oversight

- EVgo is committed to upholding the highest standards of business ethics and compliance
- EVgo's compliance programs are overseen by the Company's Chief Legal Officer
- All employees are trained annually on cybersecurity and on the Company's Code of Conduct, including promoting a harassment free environment, and Insider Trading Policy
- Strong supply chain management program in place that reflects requirements set out in our Vendor Code of Conduct
- Process audits are conducted annually to ensure supplier processes and factories are in compliance with ISO requirements and EVgo specific requirements
- Product audits are conducted as a part of qualification of a product and involves a detailed review of all the requirements in terms of design, FCC requirements, process, product, and after sales support before launching the product

All employees have access to a robust whistleblower program including:

- An independent reporting hotline hosted by a third-party with 24/7 accessibility
- Logged reports investigated and addressed as appropriate, including to ensure reports of ethical violations are handled in confidence and without fear of retaliation
